Permits: Upon acceptance of your Application you will be required to submit copies of your California Seller's Permit and a Certificate of Liability Insurance naming St. John the Baptist Greek Orthodox Church as an additional named insured.

Taxes, Licenses, Fees, & Permits: Vendor acknowledges and agrees to accept sole responsibility for payment of all legally and applicable federal, state, and local taxes, licenses, fees and permits for Vendor's merchandise sold.

Insurance: Any insurance, which may be required to cover damaged or stolen goods, is the sole responsibility of the vendor. Vendor acknowledges and agrees to accept sole responsibility for security of Vendor's merchandise and personal property at all times. Vendor hereby agrees to release and hold harmless St. John the Baptist Greek Orthodox Church for any loss of Vendor's merchandise or personal property before, during, or after the Festival.

Security: The Festival is locked every day at closing. Outside security is provided by St. John the Baptist. St. John the Baptist assumes no responsibility for loss or theft of vendor related products during the Festival.

Sale Items: Vendor agrees to provide a complete list of merchandise to be offered for sale. (fill in item description on back or attach a separate list, photographs, catalog, or product information) Merchandise not listed is prohibited and will not be allowed for sale. Vendor agrees not to sell or distribute any item listed on the Prohibited Merchandise List. Vendor merchandise display limited to inside of booth. No racks or displays are permitted outside of booth. Hanging of merchandise, fixtures, etc... on the booth canopy is prohibited. St. John the Baptist Greek Orthodox Church reserves the right to prohibit any item offered for sale by Vendor. **ITEMS NOT APPROVED, OR NOT ON YOUR LIST WILL BE PROHIBITED AT THE FESTIVAL.**
